AN UPDATE ON THE PERSONAL LOCATOR BEACON CAMPAIGN "BRINGING FISH HARVESTERS SAFELY HOME"

October 30, 2022

On February 14, 2022, a special Personal Locator Beacon campaign was launched making PLBs accessible to NL fish harvesters at 40% of the cost. The campaign was made available through a coalition of the Newfoundland and Labrador Fish Harvesting Safety Association (NL-FHSA), Fish Harvesters' Resource Centre (FRC), Professional Fish Harvesters Certification Board (PFHCB), and the Fish, Food & Allied Workers (FFAW-Unifor).

What you need to know about the campaign:

This may be your last chance to purchase a PLB at 60% off the purchase price.

A limited number of McMurdo Fast Find 220 PLB (Canada) PLBs are available for purchase. One per enterprise.

Currently, the FRC has 700 PLBs in stock in their offices and are accepting orders. This means that once you place your order, there will be no delays in shipping a PLB to you.

The full cost of a PLB is \$427.00. Your total cost to purchase a PLB is \$195.50, a cost savings of 60%.
